6. Mr. Arnott – That, in the opinion of this House, the Government of Ontario should over a twelve-year period assume responsibility for all municipal bridges in Ontario, ensuring that these all-important links between communities are properly maintained. Filed on December 11, 2007.
7. Mr. Hampton – That, in the opinion of this House, as a noble tribute to those who served in the Great Wars, the Government of Ontario give consideration to providing financial support for urgently needed repairs to the Rose Window, in the Church of the Epiphany in Woodstock, which has stood as a tribute to our fallen heroes for the past 75 years. Filed on December 11, 2007.
8. Mr. Wilson – That, in the opinion of this House, the Government of Ontario should support the Town of New Tecumseth and the Sir Frederick Banting Legacy Foundation by ensuring that the recommendations made by the Conservation Review Board on the future of the Sir Frederick Banting Homestead in Alliston are enacted and that the Government of Ontario should take every measure necessary to ensure that this property is transferred to either the Town of New Tecumseth or the Sir Frederick Banting Legacy Foundation for the purpose of creating an educational and interpretative centre on a not-for-profit basis, such as a camp for diabetic youth, and to ensure that the property is properly maintained. Mrs. Witmer – That, in the opinion of this House, the Government of Ontario should protect the children and youth of this province from the harmful effects of second-hand smoke in automobiles by immediately implementing an effective province wide campaign to educate parents about the dangers of smoking in vehicles when a person who is less than 16 years of age is present.  - b) Order a full policy review of child care in Ontario to ensure that future expansion only occurs in the not-for-profit sector upon ending the moratorium. Filed on March 17, 2008.
