Mr. Runciman – Whereas, Ontario's rural schools are the hub and heart of their communities; and

Whereas, in September 2007, the McGuinty Liberals promised they would keep rural schools open because, in the words of Premier McGuinty, "For rural kids, few things are more important than being able to go to school in your own community, with your own friends. Rural schools help keep communities strong, which is why we're not only committed to keeping them open – but strengthening them"; and

Whereas, in less than nine months after the Premier made this promise, over 50 rural schools are slated for closure;

The Legislative Assembly of Ontario calls upon Premier McGuinty to suspend any and all board-recommended rural school closures until both the funding formula review and a thorough assessment of alternate uses for rural schools have been completed. Addressed to the Premier of Ontario.

10. Mrs. Witmer – That, in the opinion of this House, the Government of Ontario should protect the children and youth of this province from the harmful effects of second-hand smoke in automobiles by immediately implementing an effective province wide campaign to educate parents about the dangers of smoking in vehicles when a person who is less than 16 years of age is present. Filed on December 13, 2007.

11. Mr. Yakabuski – That, in the opinion of this House, the Government of Ontario should introduce legislation to exempt members of the Canadian Armed Forces from liability to pay the tax known as the Ontario Health Premium and that the Government immediately discontinue charging those members for that tax. Mr. Chudleigh – Enquiry of the Ministry – Would the Minister of Transportation please explain in detail how GO Transit measures its on-time performance and indicate in detail GO Transit's on-time performance for the months of January, February and March of 2008 broken down further by performance during peak times (6:00 a.m.-9:00 a.m., 3:00 p.m.-6:00 p.m.) and off-peak times. June 2, 2008.

82. Mr. Chudleigh – Enquiry of the Ministry – Would the Minister of Transportation please explain why the rise in revenue per GO Transit passenger between 2003 and 2006 rose significantly faster than the cost per passenger during the same period. June 2, 2008.

83. Mr. Chudleigh – Enquiry of the Ministry – Would the Minister of Transportation please explain why GO Transit implemented a fare hike before releasing its Annual Report for the year ending March 2008 and indicate the extent of public consultation GO Transit undertook in deciding to increase fares and the financial information that was made public prior to that decision. June 2, 2008.

84. Mr. Chudleigh – Enquiry of the Ministry – Would the Minister of Transportation please explain why GO Transit is paying MotivePower Inc. more than \$5 million per new locomotive when the average cost for other transit authorities, including those in New Jersey, Maryland, Utah and New York City, is closer to \$3 million per locomotive. June 2, 2008.

85. Mr. Chudleigh – Enquiry of the Ministry – Would the Minister of Transportation please specify when the current locomotives were purchased, the amount spent on major refurbishments to date, and would he also specify how many years the new locomotives are expected to operate. June 2, 2008.
