Ms. DiNovo – That, in the opinion of this House, seniors 65 years of age or over, have free access to Ontario funded art galleries and museums, and that the Ontario government reimburse these galleries and museums to compensate for the drop of revenue in providing this free access. Filed on March 17, 2008.
18. Ms. DiNovo – That, in the opinion of this House, 25% of all Ontario places of employment be inspected each year. Filed on March 17, 2008.
