Ms. Horwath – That, in the opinion of this House, the Government of Ontario should designate children’s mental health as a mandated provincial program to ensure adequate, stable and sustainable funding for the sector and the valued services it provides to Ontario’s children and youth. Filed on April 23, 2008.
34. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should proclaim the first full week from Monday to Sunday in May of each year as Children’s Mental Health Week. Filed on May 5, 2008.

35. Mrs. Witmer – That, in the opinion of this House, all Ontarians deserve to have timely access to a family doctor and that the Government of Ontario must take all steps possible to recruit new doctors to the province and retain those currently practicing here by making Ontario a more attractive place to practice medicine.
