Mr. Arnott – That, in the opinion of this House, the Ministry of Tourism should establish a fund to offer loans of up to \$25,000 to qualifying annual festivals and events that have experienced dramatic declines in attendance year-over-year because of poor weather or other unforeseen events. 69. Mr. Runciman – That, in the opinion of this House, in order to adequately address serious failings of Ontario’s justice system that have resulted in deaths of innocent Ontarians, the McGuinty government should implement the following:
