Mr. Lalonde That, in the opinion of this House, in response to the current economic climate, the Ontario Government should ease the workload of business owners and allow them to focus on job creation, by permitting Ontario businesses that have a business number with the Canada Revenue Agency to use a single form when providing information relating to taxes they are required to pay under the *Employer Health Tax Act* and the *Retail Sales Tax Act* and premiums payable under the *Workplace Safety and Insurance Act*, 1997; and that updated information on this single form should be submitted to the Ministry of Finance on a quarterly basis on their assignment. Filed on May 6, 2009.
- 91. Mr. O'Toole That, in the opinion of this House, the Province of Ontario should act immediately to convene a Select Committee that will review Ontario's current policies on pensions and consult with all Ontarians to develop measures that will ensure pensions remain viable and protected.
