That pursuant to Standing Order 47 and notwithstanding any other Standing Order or Special Order of the House relating to Bill 175, An Act to enhance labour mobility between Ontario and other Canadian provinces and territories, when the Bill is next called as a Government Order the Speaker shall put every question necessary to dispose of the Second Reading stage of the Bill without further debate or amendment and at such time the Bill shall be ordered referred to the Standing Committee on Justice Policy; and

That the Standing Committee on Justice Policy be authorized to meet on Thursday, December 3, 2009, during its regular meeting times for the purpose of public hearings on the Bill and following Routine Proceedings on Monday, December 7, 2009 for clause-by-clause consideration of the Bill; and

That the deadline for filing amendments to the Bill with the Clerk of the Committee shall be 12:00 noon on Friday, December 4, 2009. At 5:00 p.m. on Monday, December 7, 2009, those amendments which have not yet been moved shall be deemed to have been moved, and the Chair of the Committee shall interrupt the proceedings and shall, without further debate or amendment, put every question necessary to dispose of all remaining sections of the Bill and any amendments thereto. The Committee shall be authorized to meet beyond the normal hour of adjournment until completion of clause-by-clause consideration. Any division required shall be deferred until all remaining questions have been put and taken in succession with one 20-minute waiting period allowed pursuant to Standing Order 129(a); and

That the Committee shall report the Bill to the House no later than Tuesday, December 8, 2009. In the event that the Committee fails to report the Bill on that day, the Bill shall be deemed to be passed by the Committee and shall be deemed to be reported to and received by the House; and

That, upon receiving the report of the Standing Committee on Justice Policy, the Speaker shall put the question for adoption of the report forthwith, and at such time the Bill shall be Ordered for Third Reading; and

That, when the Order for Third Reading of the Bill is called, the Speaker shall put every question necessary to dispose of this stage of the Bill without further debate or amendment; and

That there shall be no deferral of the Second Reading or Third Reading votes allowed pursuant to Standing Order 28(h); and

That, in the case of any division relating to any proceedings on the Bill, the division bell shall be limited to 5 minutes. (Time used: 0 hrs. 40 mins.).

Whereas, the McGuinty government, despite repeated calls by the Official Opposition, has failed to appoint an independent investigator to look into the tragic and preventable deaths caused by C. difficile in Ontario and has also refused to allow the Ombudsman to investigate the outbreak; and

Whereas, the McGuinty government, despite repeated calls by the Official Opposition, has failed to call a public inquiry, so that the public would know why these preventable deaths occurred and steps could be taken to prevent further deaths related to C. difficile in hospitals throughout Ontario; and

Whereas, the McGuinty government has failed to reassure the public by providing a comprehensive plan to combat C. difficile, putting the public at further risk of contracting C. difficile in Ontario hospitals; The government no longer has the confidence of this House. Filed on June 18, 2008.

Mr. Sterling – That, in the opinion of this House, the Government of Ontario must demonstrate its belief in the principle of representation by population by addressing the inequity in representation at the provincial level through the creation of an Independent Boundaries Commission to ensure Ontarians receive equal and effective representation as guaranteed in the Charter of Rights in their provincial legislature before the Government of Ontario can demand fair representation by population for Ontarians within the House of Commons. Filed on December 3, 2007.

4. Mr. Rinaldi – That, in the opinion of this House, the Legislative Assembly should support the Cobourg Police Service, the Ontario Association of Chiefs of Police, the Ontario Provincial Police and Premier McGuinty's calls for the Governor General of Canada and the Prime Minister of Canada to recognize that acts of bravery have no expiry date and award Constable Chris Garrett with the Cross of Valour that his heroic efforts deserve. Filed on December 4, 2007.

5. Mr. Hudak – That, in the opinion of this House, the Ministry of Natural Resources should create and fund a shared cost gypsy moth spraying program to circumvent the ongoing spread of moth-infested trees and woodlots causing damage to personal property, parks, and the environment, with municipalities that have demonstrated a need or interest such as Hamilton and Niagara. Filed on December 10, 2007.

6. Mr. Arnott – That, in the opinion of this House, the Government of Ontario should over a twelveyear period assume responsibility for all municipal bridges in Ontario, ensuring that these all-important links between communities are properly maintained. Filed on December 11, 2007.

7. Mr. Hampton – That, in the opinion of this House, as a noble tribute to those who served in the Great Wars, the Government of Ontario give consideration to providing financial support for urgently needed repairs to the Rose Window, in the Church of the Epiphany in Woodstock, which has stood as a tribute to our fallen heroes for the past 75 years. Filed on December 11, 2007.

8. Mr. Wilson – That, in the opinion of this House, the Government of Ontario should support the Town of New Tecumseth and the Sir Frederick Banting Legacy Foundation by ensuring that the recommendations made by the Conservation Review Board on the future of the Sir Frederick Banting Homestead in Alliston are enacted and that the Government of Ontario should take every measure necessary to ensure that this property is transferred to either the Town of New Tecumseth or the Sir Frederick Banting Legacy Foundation for the purpose of creating an educational and interpretative centre on a not-for-profit basis, such as a camp for diabetic youth, and to ensure that the property is properly maintained. 9. Mr. Barrett – That, in the opinion of this House, the following Order of Reference should be assigned to an all-Party committee of the Legislative Assembly:

To inquire into and report on native land issues within the Province of Ontario.

The Committee shall:-

- 1. Conduct public hearings on this issue at Queen's Park and in at least 7 other Ontario communities;
- 2. Solicit input from Ontario citizens on their knowledge, experience and action proposals with respect to native land issues;

3. Present its report to the House, containing its observations, opinions and recommendations no later than the end of 2008. Filed on December 12, 2007.

10. Mrs. Witmer – That, in the opinion of this House, the Government of Ontario should protect the children and youth of this province from the harmful effects of second-hand smoke in automobiles by immediately implementing an effective province wide campaign to educate parents about the dangers of smoking in vehicles when a person who is less than 16 years of age is present. Filed on December 13, 2007.

11. Mr. Yakabuski – That, in the opinion of this House, the Government of Ontario should introduce legislation to exempt members of the Canadian Armed Forces from liability to pay the tax known as the Ontario Health Premium and that the Government immediately discontinue charging those members for that tax. Filed on December 13, 2007.

12. Ms. DiNovo – That, in the opinion of this House, the Ontario Government should support the Federal motion to urge the government of the People's Republic of China and representatives of Tibet's government in exile, to continue their dialogue in a forward looking manner that will lead to pragmatic solutions that respect the Chinese constitutional framework, the territorial integrity of China and fulfill the aspirations of the Tibetan people for a unified and genuinely autonomous Tibet. Filed on March 17, 2008.

13. Ms. DiNovo – That, in the opinion of this House, the Government of Ontario should immediately commence construction of not-for-profit rent geared to income housing units in order to keep its election promise of building 26,600 units; and begin to meet the housing needs of the 125,000 Ontarians on the waiting lists for affordable housing. Filed on March 17, 2008.

14. Ms. DiNovo – That, in the opinion of this House, the Government of Ontario should immediately end the clawback of the National Child Benefit Supplement from all families in Ontario. Filed on March 17, 2008.

15. Ms. DiNovo – That, in the opinion of this House, the powers of the Ontario Municipal Board be amended so that they are not able to undermine the authority of democratically elected city councils in decisions such as land use planning and others. Filed on March 17, 2008.

16. Ms. DiNovo – That, in the opinion of this House, seniors 65 years of age or over, have free access to Ontario funded art galleries and museums, and that the Ontario government reimburse these galleries and museums to compensate for the drop of revenue in providing this free access. Ms. MacLeod – That, in the opinion of this House, the Legislative Assembly should televise its proceedings online at www.ontla.on.ca; should make arrangements to have Bell Canada (including Satellite) televise proceedings (as Rogers Cable does) as part of their basic package; and should arrange with provincially funded cable stations TVO and TFO that daily Question Period is televised, in order to provide all residents of Ontario, particularly those in rural Ontario who do not have access to other cable sources, with access to the daily proceedings at Queen's Park. Filed on April 9, 2008.

27. Ms. Jones – That, in the opinion of this House, the Government of Ontario should immediately expand the Foodland Ontario program to include a designation for organically grown products and expand their Foodland Ontario logo to include the word "organic" where appropriate. Filed on April 15, 2008.

30. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Training, Colleges and Universities should immediately make the necessary regulatory changes to accommodate the construction and manufacturing trades so that the ratio of journeyman trades-people to apprentices be one-to-one. Filed on April 21, 2008.

31. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should order a stand-alone inquest into the March 2006 murder of eight-year old Jared Osidacz, using the powers vested in the Minister of Community Safety and Correctional Services under Section 22 of The Coroners Act. Filed on April 21, 2008.

32. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should designate children's mental health as a mandated provincial program to ensure adequate, stable and sustainable funding for the sector and the valued services it provides to Ontario's children and youth. Filed on April 23, 2008.

34. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should proclaim the first full week from Monday to Sunday in May of each year as Children's Mental Health Week. Filed on May 5, 2008.

Mrs. Witmer – That, in the opinion of this House, all Ontarians deserve to have timely access to a family doctor and that the Government of Ontario must take all steps possible to recruit new doctors to the province and retain those currently practicing here by making Ontario a more attractive place to practice medicine. Filed on May 26, 2008.

39. Mr. Hillier – That, in the opinion of this House, the Business Education Tax be either eliminated or set at the same rate throughout Ontario to prevent the Ontario government from favouring the economic development of some municipalities at the expense of other Ontario municipalities by using differential business tax rates. Filed on May 26, 2008.

40. Ms. DiNovo – That, in the opinion of this House, the Government of Ontario should strongly encourage the Government of Canada and Canada Post to issue a commemorative stamp to honour the life of Swedish humanitarian Raoul Wallenberg, honourary citizen of Canada and one of the Holocaust's many heroes. Filed on May 27, 2008.

41. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should instruct all Children's Aid Societies to publish information electronically on their websites, where available, and in print format, readily accessible in the lobby area of each CAS office, which informs the public of their ability to attend and make presentations at the regularly scheduled Board of Director's meetings, the schedule and Minutes of those meetings, and further, in the same manner as mentioned above, to inform the public of the fact that CAS memberships are available to people who reside in, or who conduct business within the jurisdiction of each CAS, to provide details on how to apply for membership, and to provide access to the Society's By-Laws in the same manner. Filed on June 2, 2008.

42. Ms. DiNovo – That, in the opinion of this House, Ontario Government officials not take part in the opening ceremonies of the Olympic Games in keeping with the wishes of his Holiness the Dalai Lama and the Tibetan people so as to encourage the talks between emissaries of the Tibetan people and the People's Government of China. Filed on June 3, 2008.

43. Mr. Lalonde – That, in the opinion of this House, June 3rd be declared "Glengarry-Prescott-Russell Day" at Queen's Park, and that the date may not be changed without the approval of the majority of the municipalities in the riding of Glengarry-Prescott-Russell. Should June 3rd fall on a Friday, Saturday, or Sunday, Glengarry-Prescott-Russell day at Queen's Park will take place the following Monday. Filed on June 3, 2008.

43. M. Lalonde – Que, de l'avis de cette Assemblée législative, le 3 juin de chaque année soit déclaré le « jour de Glengarry-Prescottt-Russell » à Queen's Park et que la date ne puisse être changée sans l'approbation de la majorité des municipalités de la circonscription de Glengarry-Prescott-Russell. Ms. DiNovo – That, in the opinion of this House, in recognition of the suffering from recent earthquakes of the Tibetan people and in conjunction with the Ontario Parliamentary Friends of Tibet and the Parliamentary Friends of Tibet in Ottawa, the torch relay of the 2008 Olympics not pass through Tibet. Filed on June 4, 2008.

47. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should, in support of Ontario's farmers and growers, direct all provincial public institutions such as hospitals and health care facilities, schools, universities and colleges, government ministries, agencies, boards and commissions, etc., wherever possible, to purchase Ontario grown produce and flowers on occasions where such are required. Filed on June 17, 2008.

48. Ms. MacLeod – That, in the opinion of this House, the Legislative Assembly should proclaim the twentieth (20^{th}) day of November each year as Provincial Day of the Child to coincide with International and National Children's Day. Filed on September 22, 2008.

49. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should immediately approve Zenn cars and electric bicycles, as defined by Transport Canada in 2001, for permanent, legal use on Ontario roads, with the exception of 400-series highways. Filed on September 22, 2008.

53. Ms. Horwath – That, in the opinion of this House, the Ombudsman of Ontario should be granted oversight over child welfare and protection decisions so that families have a truly independent appeal mechanism available to investigate any concerns. Filed on October 6, 2008.

54. Ms. Horwath – That, in the opinion of this House, Autism Awareness Month should be officially recognized and publicly acknowledged in the Ontario Legislature in October of every year. Filed on October 6, 2008.

57. 61. Mr. Colle – That, in the opinion of this House, the month of November should be proclaimed as Crohn's and Colitis Awareness Month, in concert with the same designation by the Federal Health Minister in 2006, to recognize the courage of more than 200,000 Ontarians living with Crohn's and Colitis and to encourage Ontarians to make finding a cure for inflammatory bowel disease a priority. Filed on October 29, 2008.

63. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should ensure that the Sarnia (Erie-St.Clair) Pathways program of in-school occupational therapy, physiotherapy and speech language pathology for children with disabilities is preserved, first and foremost, and strengthened over time through appropriate Ministry investments in these children's services. Filed on November 18, 2008.

64. Mr. Barrett – That, in the opinion of this House, families adjacent to the Douglas Creek Estates subdivision in Caledonia must be offered adequate and appropriate compensation, beyond anything negotiated to date, for their subjection to social, economic and psychological distress since the illegal occupation by native activists on February 28, 2006; so–called OPP "no-go zones" must be eliminated and OPP patrols and protection restored to these zones, as well as to the subdivision; and the subdivision must be restored to its former status as a residential subdivision. Filed on November 19, 2008.

68. Mr. Arnott – That, in the opinion of this House, the Ministry of Tourism should establish a fund to offer loans of up to \$25,000 to qualifying annual festivals and events that have experienced dramatic declines in attendance year-over-year because of poor weather or other unforeseen events. Filed on November 26, 2008.

69. Mr. Runciman – That, in the opinion of this House, in order to adequately address serious failings of Ontario's justice system that have resulted in deaths of innocent Ontarians, the McGuinty government should implement the following:

a) Institute a policy of instructing Crowns to appeal all bail release decisions related to the commission of a crime with a weapon, possession of a weapon, and aggravated sexual assault;

b) Immediately invest, through reallocations, in a dramatically expanded electronic monitoring program, with instructions to Crowns that monitoring is requested when courts grant bail to individuals they, or police, believe pose a threat to public safety;

c) Institute greater restrictions on the Crown's ability to plea bargain, without first receiving consent of victims and police, on charges of crime with a weapon, possession of a weapon, and aggravated sexual assault;

d) Enforce and collect all bail forfeitures; and

e) Upgrade electronic information sharing among justice system partners to ensure courts have all relevant information when making bail and sentencing decisions. Filed on November 27, 2008.

71. Mr. Arnott – That, in the opinion of this House, the Government of Ontario should complete the environmental assessment and, by September 1, 2011 at the latest, extend GO Transit rail service to include stops in the Acton area, Guelph, and the Kitchener-Waterloo area. Filed on December 3, 2008.

72. Mr. Runciman – That, in the opinion of this House, the Ontario legislature expresses its grave concerns about the possibility that the Government of Canada might consist of a coalition that includes a separatist party committed to the breakup of Canada. Filed on December 3, 2008.

73. Ms. DiNovo – That, in the opinion of this House, Primary Prevention programs such as the Boost Child Abuse Prevention and Intervention program be mandatory in all Ontario Elementary Schools as requested by the family of Holly Jones. Filed on December 8, 2008.

74. Ms. Horwath – That, in the opinion of this House, the Government of Ontario should resume direct responsibility, control and oversight of provincial safety regulations by withdrawing the inherently conflicted self-regulation and self-funding model of the Technical Standards and Safety Authority. Filed on December 9, 2008.

84. Mrs. Van Bommel – That, in the opinion of this House, the Legislative Assembly of Ontario joins the Government of Canada in expressing concerns with the proposed laws in Afghanistan that would severely restrict the rights of Afghan women and that we, the Legislative Assembly of Ontario, express our firm solidarity with the women of a democratic Afghanistan. Filed on April 9, 2009.

85. Ms. DiNovo – That, in the opinion of this House and due to the economic circumstances we are experiencing in Ontario, rents will be declared frozen, beginning June 1, 2009 until June 1, 2010. Filed on April 20, 2009.

90. Mr. Lalonde – That, in the opinion of this House, in response to the current economic climate, the Ontario Government should ease the workload of business owners and allow them to focus on job creation, by permitting Ontario businesses that have a business number with the Canada Revenue Agency to use a single form when providing information relating to taxes they are required to pay under the *Employer Health Tax Act* and the *Retail Sales Tax Act* and premiums payable under the *Workplace Safety and Insurance Act, 1997;* and that updated information on this single form should be submitted to the Ministry of Finance on a quarterly basis on their assignment. Filed on May 6, 2009.

91. Mr. O'Toole – That, in the opinion of this House, the Province of Ontario should act immediately to convene a Select Committee that will review Ontario's current policies on pensions and consult with all Ontarians to develop measures that will ensure pensions remain viable and protected. Filed on May 6, 2009.

92. Mr. O'Toole – That, in the opinion of this House, the Province of Ontario should review the mandate of provincial Local Health Integration Networks (LHINs) to ensure policies established by the LHINs do not result in Ontario's smaller rural and community hospitals losing the level of service that they currently provide; and that in the opinion of this House, the Province of Ontario must act immediately to reaffirm its commitment to the principle of quality care, delivered close to home, by Ontario's community hospitals; and furthermore, that the Ministry of Health and Long-Term Care establish specific dates and times when all community hospitals will receive annual funding, based on a formula approved by the Ontario Hospital Association and based on the principles of both need and population. Filed on May 6, 2009.

93. Mr. Shurman – That, in the opinion of this House, the term Israel Apartheid Week is condemned as it serves to incite hatred against Israel, a democratic state that respects the rule of law and human rights, and the use of the word 'apartheid' in this context diminishes the suffering of those who were victims of a true apartheid regime in South Africa. Filed on May 11, 2009.

94. Mrs. Munro – That, in the opinion of this House, the 8% sales tax increase will have a devastating effect on Ontario's cultural industries; that increasing the cost of admission to movies, live theatre, art galleries, concerts, festivals and other artistic events by 8% will reduce attendance, costing jobs and restricting the public's access to culture. Filed on May 13, 2009.

95. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Transportation support our Canadian troops by designing a graphic licence plate, that would incorporate a yellow ribbon and maple leaf, for Ontario citizens to purchase. Filed on May 13, 2009.

96. Ms. Aggelonitis – That, in the opinion of this House, southern Ontario, and particularly Hamilton, would be an ideal location for a National Hockey League franchise, from which both the NHL and southern Ontario would derive significant economic benefit, and to this end the Legislative Assembly of Ontario lends its full support to any effort to relocate a NHL franchise to Hamilton or surrounding areas within southern Ontario. Filed on May 14, 2009.

97. Mr. Arnott – That, in the opinion of this House, the Government should keep its promise to Ontario's volunteer firefighters by extending to them the same presumptive workers' compensation coverage already protecting full-time firefighters as a result of the passage of Bill 221. Filed on May 25, 2009.

98. Mr. Murdoch – That, in the opinion of this House, the Government of Ontario should support those Ontarians living with epilepsy by declaring March 26, Epilepsy Awareness Day in the Province of Ontario. Filed on May 26, 2009.

99. Mr. O'Toole – That, in the opinion of this House, the Government of the Province of Ontario has a clear and important responsibility to protect the citizens of Ontario by:

- developing a made-in-Ontario Nuclear Waste Management Plan;
- taking a lead role while working with their Federal counterpart and other stakeholders to develop a responsible nuclear waste management plan;
- working with the partners to develop a nuclear waste management education and awareness plan; and
- ensuring that communities that deal with nuclear waste have all the resources needed to provide for the preparedness, responsiveness and long-term safety of their communities and regions. Filed on May 27, 2009.

101. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Community Safety and Correctional Services should consider replacing a system of right to strike with compulsory binding arbitration for correctional officers in the Province of Ontario. Filed on June 2, 2009.

102. Ms. DiNovo – That, in the opinion of this House, any new trains purchased and operative in Ontario should be electric. This being a long term cost saving for residents taking into account future health consequences and expenses; diesel trains being more polluting than the cars they would be replacing. Filed on June 3, 2009.

103. Mr. O'Toole – That, in the opinion of this House, the Government of Ontario has a clear and necessary responsibility to protect the senior citizens of Ontario from abuse, of both the financial and physical nature, by stringently overseeing power of attorney for property and power of attorney for personal care implementation; furthermore, the regulations surrounding this implementation must be transparent and accessible to the grantor and family members involved, so that senior citizens, who so often experience manipulation and abuse, can be rightfully protected. Filed on June 4, 2009.

106. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Community Safety and Correctional Services should provide the necessary funding to equip and train all front-line police officers with Conducted Energy Weapons. Filed on September 15, 2009.

107. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministry of Children and Youth Services should provide the necessary funding to create a Child Advocacy Centre in the County of Simcoe. Filed on September 15, 2009.

112. Mr. Marchese – That, in the opinion of this House, the Government of Canada should launch a public inquiry into the Suaad Hagi Mohamud case to ensure that it is not repeated; and should provide Ms. Mohamud with reasonable compensation for the mental, physical and emotional distress suffered by Ms. Mohamud and her family, as well as the damage to Ms. Mohamud's reputation. Filed on September 29, 2009.

115. Mr. Dunlop – That, in the opinion of this House, the Government of Ontario and its Ministries of Labour and Education should create effective anti-bullying policies and procedures to ensure physical and psychological well being in our schools and workplaces. Filed on October 20, 2009.

Mr. Runciman – **REASONED AMENDMENT** – That the motion for Second Reading of Bill 212, An Act to promote good government by amending or repealing certain Acts and by enacting two new Acts, be amended by deleting all the words after "That" and substituting therefore the words "That this Bill be NOT now read a Second time but be referred back to the Government with instructions to incorporate therein:

1. that Schedules 5, 6 and 21 in Bill 212 be deleted; and

2. that each of the said Schedules be introduced as separate Public Bills. Filed on October 29, 2009.

121. Ms. DiNovo – That, in the opinion of this House, the Government immediately institute a housing credit for those on social assistance as requested by anti-poverty activists such as the Daily Bread Food Bank. Filed on November 18, 2009.

122. Reasoned Amendment by Mr. Miller (Parry Sound–Muskoka) to the motion for Second Reading of Bill 218, An Act to implement 2009 Budget measures and to enact, amend or repeal various Acts. Debated November 23, 24, 25 and 26, 2009.

123.
