That the Committee be authorized to meet from Tuesday September 1, 2015 to Thursday September 4, 2015 and Tuesday September 8, 2015 to Thursday September 10, 2015 from 9:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m. on each of the respective days for the purpose of clause-by-clause consideration of the Bill; and

On Wednesday September 9, 2015, at 3:00 p.m., those amendments which have not yet been moved shall be deemed to have been moved, and the Chair of Committee shall interrupt the proceedings and shall, without further debate or amendment, put every question necessary to dispose of all remaining sections of the Bill and any amendments thereto.

At this time, the Chair shall allow one 20-minute waiting period pursuant to Standing Order 129(a); and

At this time, the Chair shall allow one 20-minute waiting period pursuant to Standing Order 129(a); and

That the Committee shall report the Bill to the House no later than Tuesday, June 2, 2015. In the event that the Committee fails to report the Bill on that day, the Bill shall be deemed to be passed by the Committee and shall be deemed to be reported to and received by the House; and
