- Notice of public hearings on the Ontario Parliamentary Channel, the Legislative Assembly's website and Canada NewsWire; and
- That the deadline for requests to appear be 12:00 noon on Friday, November 13, 2015; and
- That following the deadline, the Clerk of the Committee provide the members of the Committee with a list of requests to appear; and
- That a member from all three recognized parties prioritize and return the list by 6:00 p.m. on Friday, November 13, 2015; and
- That the Clerk of the Committee schedule witnesses from these prioritized lists; and

- That each witness will receive up to 15 minutes for their presentation followed by 9 minutes for questions from Committee members; and
- That the deadline for written submissions be 6:00 p.m. on Thursday, November 26, 2015; and

That the deadline for filing amendments to the Bill with the Clerk of the Committee shall be 12:00 noon on Friday, November 27, 2015; and

That the Committee be authorized to meet on Monday, November 30, 2015 at its regularly scheduled time for the purpose of clause-by-clause consideration of the Bill.

On Monday, November 30, 2015, at 5:00 p.m., those amendments which have not yet been moved shall be deemed to have been moved, and the Chair of the Committee shall interrupt the proceedings and shall, without further debate or amendment, put every question necessary to dispose of all remaining sections of the Bill and any amendments thereto. At this time, the Chair shall allow one 20-minute waiting period pursuant to Standing Order 129(a); and

That the Committee shall report the Bill to the House no later than Wednesday, December 2, 2015.

Ordered, That, pursuant to Standing Order 47 and notwithstanding any other Standing Order or Special Order of the House relating to Bill 115, An Act to enact the Representation Act, 2015, repeal the Representation Act, 2005 and amend the Election Act, the Election Finances Act and the Legislative Assembly Act, when the Bill is next called as a Government Order, the Speaker shall put every question necessary to dispose of the Second Reading stage of the Bill without further debate or amendment and at such time the Bill shall be Ordered referred to the Standing Committee on Social Policy; and

That the Standing Committee on Social Policy be authorized to meet on Monday, November 23, 2015, from 2:00 p.m. to 6:00 p.m., and Tuesday, November 24, 2015 from 4:00 p.m. to 6:00 p.m. for the purpose of public hearings on the Bill; and

That the Clerk of the Committee, in consultation with the Committee Chair, be authorized to arrange the following with regard to Bill 115:

- Notice of public hearings on the Ontario Parliamentary Channel, the Legislative Assembly's website and Canada NewsWire; and

That the Committee be authorized to meet on Thursday, November 26, 2015, from 1:00 p.m. to 4:00 p.m., in Toronto, for the purpose of clause-by-clause consideration of the Bill.

On Thursday, November 26, 2015, at 2:00 p.m., those amendments which have not yet been moved shall be deemed to have been moved, and the Chair of the Committee shall interrupt the proceedings and shall, without further debate or amendment, put every question necessary to dispose of all remaining sections of the Bill and any amendments thereto. At this time, the Chair shall allow one 20-minute waiting period pursuant to Standing Order 129(a); and

That the Committee shall report the Bill to the House no later than Monday, November 30, 2015.

In the event that the Committee fails to report the Bill on that day, the Bill shall be deemed to be passed by the Committee and shall be deemed to be reported to and received by the House; and
