That the Clerk of the Committee, in consultation with the Committee Chair, be authorized to arrange the following with regard to Bill 32:

- That the deadline for requests to appear be 4:00 p.m. on Monday, October 29, 2018; and
- That, the Clerk of the Committee provide a list of all interested presenters to each member of the Sub-committee and their designate following the deadline for requests to appear by 6:00 p.m. on Monday, October 29, 2018; and
- That, each member of the Sub-committee or their designate provide the Clerk of the Committee with a prioritized list of presenters to be scheduled, chosen from the list of all interested presenters received by the Clerk by 10:00 a.m. on Tuesday, October 30, 2018; and
- That each witness will receive up to ten minutes for their presentation followed by ten minutes divided equally amongst the recognized parties for questioning; and
